Diploma in Business and Research Analysis the overall business and IT needs of an organization in order to develop appropriate solution strategies. As the key liaison between business and information technology departments, the business analyst is responsible for gathering and documenting business requirements and translating them into functional system design specifications that can be successfully executed by IT development teams.

A Business Analyst is someone who analyses change requirements and produces a justifiable set of analysis deliverables that are used to design and implement the solution. A Business Analyst is (or should!) be measured on delivery of the benefits specified in the project objectives.

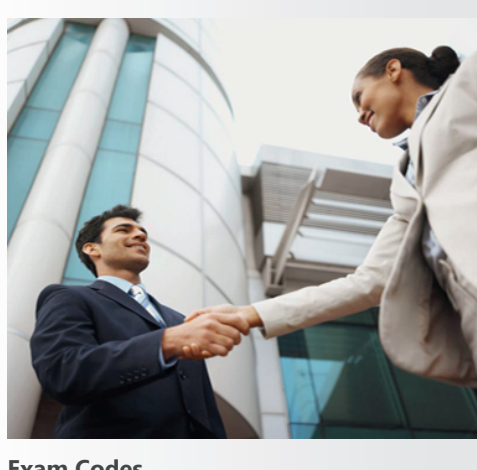
